Invitation Bids for Swanagaun-Gairigaun Road Improvement

1. The **Dhunibeshi Municipality, Dhading** invites electronic bids from eligible bidders for the procurement of **Swanagaun-Gairigaun Road Improvement Second** under National competitive bidding - Single Stage Single Envelope procedures.
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Dhunibeshi Municipality, Dhading** or may visit PPMOegp system www.bolpatra.gov.np/egp.
3. Eligible Bidders may obtain further information and inspect the bidding documents through e-GP system www.bolpatra.gov.np/egp. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document **Nrs. 3000** in the following Rajaswa (revenue) account as specified below.

4. Pre-bid meeting shall be held at **Dhunibeshi Municipality, Dhading** at **2080/02/10 on 13:00**.
5. Electronic bids must be submitted to the office **Dhunibeshi Municipality, Dhading** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 on 2080/20/31**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on 2080/02/31** at the office of **Dhunibeshi Municipality, Dhading**. Bids must be valid for a period of **120 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs as explain below., which shall be valid for 30 days beyond the validity period of the bid .
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
